JOINING PROCEDURES

- i. An Application Form must be completed and sent, along with the correct payment, to the Membership Secretary at the address shown below. Cheques should be made payable to the Towy Boat Club. Please see the current Tariff sheet for Membership charges.
- ii. All applicants **MUST** come to the monthly Club Committee Meeting in person for their application to be approved. Meetings are held at the Clubhouse on the **FIRST** Wednesday of every month, starting at 7.30 pm.
- iii. The Membership Secretary will confirm your election to Membership in the meeting. A copy of the Club Programme and a car park sticker for the current year will then be provided to each new member, plus any keys purchased.
- iv. Working parties are held monthly on the Saturday following the Committee meeting. All Members are requested to assist in this valuable work of maintaining and upgrading Club. Where time or distance prevents this, members may make occasional voluntary contributions to the Maintenance Fund.
- v. If you require Moorings and/or Storage these requirements should be discussed with the Dinghy / Cruiser Secretaries and the Moorings Officer. All boats used or stored on Club premises must as a minimum have Third Party Insurance of not less than £3m. Proof must be produced at the request of the Club Management and assurance given at Membership renewal that adequate arrangements are in place.
- vi. All new members who are issued with a mooring, either Temporary or Permanent, **MUST** purchase all necessary mooring tackle from the Club, unless otherwise agreed by the Moorings Sub-Committee
- vii. Members are required to abide by all Club Rules and Regulations, a copy of which is displayed in the Club House. All new Members will be also be provided with a copy of the Constitution on joining the Club on request.
